### **Shooting Requirements**

NAPWC Video Filming and Photography Request Form and Facilities Request Form

### **Details of Requirements**

These Request Forms must be accomplished by the client and approved by NAPWC Management. The Commercial Filming and Photography Request Form does not

include permission to conduct commercial filming within the Wildlife Rescue Center which is managed by DENR-BMB-WRD.

### **Access Hours**

Monday to Sunday 8:00 AM to 5:00 PM\*

\*Filming at hours beyond this range must be coordinated with and approved by NAPWC Management.

#### **Restrictions or Limitations**

Park visitors are not allowed within range of facilities under construction and maintenance, such as the Amphitheatre, Gazebo, Make-up Room, and Plant Nursery.

Bulwagang Ninoy, Cottages near the Training Center and the Training Center, itself, is not open for public reservations. These facilities are for the exclusive use of DENR and authorized government use.

As a protected area, picking of flowers/plants, vandalism, poaching, hunting, gathering timber, littering, introducing exotic species (see Section 20, DAO 2019-05) are strictly prohibited. Park Visitors are also discouraged from entering the premises of the Arboretum area without safety boots. This area within the park is considered a strict protection zone, which prohibits human interventions. Thus, flora are left alone to thrive in these parts and there is a possibility of encountering a snake. The presence of a variety of such fauna is considered an indication of good forest condition.

Drones and other Remotely Operated Devices are prohibited.

Unauthorized motor vehicles are restricted to designated parking area at the North Avenue (Gate 2).

Biking within the premises is not allowed (Park visitors must leave their bikes at the bike racks near each gate).

Cooking within the premises is not allowed. Food deliveries may be picked up at the Delivery "Pick-Up and Drop Off" Points at each gate.

Weapons are prohibited. Other Prohibited items include the following: Single-use Plastics such as water bottles, balloons, Styrofoam and the like (BMB Circular No. 2019-01 dated May 30, 2019).

### **Security Requirements**

We require Park Visitors' Ticket Inspection and Facilities Rental Permit Inspection.

### **Prohibited Equipment**

Drones and other Remotely Operated Devices are prohibited.

Other Prohibited items include the following: Single-use Plastics such as water bottles, balloons, Styrofoam and the like (BMB Circular No. 2019-01 dated May 30, 2019).

Biking within the premises is not allowed (Park visitors must leave their bikes at the bike racks near each gate).

Cooking Equipment and Weapons are prohibited.

Setting up of Tents is only allowed within the Basketball Court area.

Sound systems, including portable Bluetooth or wired speakers and videoke, is prohibited within the picnic sheds to help preserve the park's peaceful and natural ambiance and minimize noise pollution by ensuring that each area complies with its intended purpose. Picnic sheds are designed for smaller gatherings, typically accommodating up to 10 people, and are intended to provide a quieter and more intimate setting within the park. For larger gatherings and events, we have facilities such as the fishing village which can accommodate up to 70 and 100 people, respectively, and are better suited for sound system use.

### **Power Sources Available**

Electrical outlets at facilities are available for rent (Picnic Shed, Tea house, Fishing Village). There is an additional fee of Php 100.00/hr for electricity use.

### **Space for Equipment Storage**

Facilities are available for rent (Picnic Shed, Tea house, Fishing Village). Picnic Shed includes built-in chairs and a table but Picnic Shed and Tea house do not have chairs and tables. As of October 10, 2024, there is no chair and table rental service within NAPWC.

#### **Onsite Facilities**

As of October 10, 2024, there are a number of restrooms situated around the park, and a designated Open Parking area near the North Avenue Gate. This parking area is separate from the parking area allocated for BMB Staff.

### **Set-up and Clean-up Time**

Park visitors are encouraged to keep within park opening hours. However, set-up time and clean-up time beyond 8:00 AM to 5:00 PM must be coordinated with and approved by NAPWC Staff.

### **Parking Information**

Designated Parking area is available near the basketball court. Equipment can be dropped off but on-street parking is not allowed. All vehicles must return to the designated parking area after drop-offs.

### **Weather Considerations**

Park Closure Advisory shall be issued and enforced in case of severely inclement weather (strong wind and/or strong rain) for park visitors' safety. Any prior facility reservations by park visitors will be cancelled or rescheduled in coordination with the NAPWC Staff. NAPWC also complies to notices of suspension of government work within Quezon City and the park will be closed following such announcements.

# **Special Instructions/Additional Notes**

The Ninoy Aquino Parks and Wildlife Center is a protected area under the Expanded National Integrated Protected Areas System Act of 2018 (RA 11038). Photographers and filmmakers interested in conducting activities within the park must abide by the rules or they will be penalized according to the law.
